History and Background



Mahidol University's origin is linked to the establishment of the University of Medical Sciences in 1943. Later in 1964 the university was renamed as Mahidol University by H.M.King Bhumibol Adulyadej in honor of his Royal Father. At that time, it was planned Mahidol University would expand beyond its focus on medicine and public health to encompass the social sciences as well. This came to fruition in 1969 when Mahidol University was officially endorsed by H.M. King Bhumibol Adulyadej along with a charter from the Office of the Prime Minister establishing the Faculty of Social Sciences and Humanities; the 12th faculty at Mahidol University.

In 1972, the university appointed Professor Chatchawan Osathanon, M.D., former rector of Mahidol University, as an interim and first dean of the Faculty of Social Sciences and Humanities. The first mission was to create a curriculum and to provide general education for undergraduate students.

In 1974, the faculty was granted permission to re-organize into three departments plus the Office of the Dean. These three departments comprised the Department of Social Sciences, the Department of Humanities, and the Department of Education. Thereafter, the faculty began to offer master degrees and then other graduate studies.

In 1982, the faculty was among the first faculties that moved from Phayathai campus in Bangkok to Salaya campus in Nakhon Pathom province. In 2010, the faculty established a fourth department, the Department of Society and Health. Nowadays, the Faculty of Social Sciences and Humanities consists of four departments and four administrative offices.

Departments and Offices

Department of Social Sciences

The Department of Social Sciences is responsible for providing academic teaching and research in the field of social sciences. The department offers 13 programs including 5 doctoral degree programs, 7 master degree programs, and 1 bachelor degree program. These programs are specialized in the fields of criminology and justice administration, public administration, environmental social science, and medical records.

Department of Education

The Department of Education is responsible for providing academic teaching and research in the fields of population studies, environmental education, educational management, sport management, and social programs evaluation. The department has 5 current doctoral degree programs as well as 4 master degree programs.

Department of Humanities

The Department of Humanities is responsible for providing academic teaching and research in the fields of religious studies and ethical studies. The department offers 1 master degree program and 1 doctoral degree program in religions and development.

Department of Society and Health

The Department of Society and Health is committed to educate, to gain further knowledge, and to serve for the betterment of health and society. The department brings together experts from diverse disciplinary backgrounds and experiences to work together in addressing health implications of social factors through education, research, training and community services. It has earned a proven track record of galvanizing students to be catalysts for change domestically and regionally. The department offers 2 doctoral degree programs and 2 master degree programs (including an international program).

Office of the Dean

The Office of the Dean is responsible for overall administration of the faculty. The Office of the Dean consists of 4 sections as follows:

- General Administration Section comprises General Administration Unit and Information Technology Development and Support Unit
- Finance and Assets Section comprises Finance and Accounting Unit and Supply Unit
- Human Resources Section
- Strategic Planning and Budgeting Section comprises Strategic Planning and Budgeting Unit, Integrated Coordination and Monitoring Unit, and International Relations and Corporate Communication Unit

Office of Research and Academic Services

Within the Faculty of Social Sciences and Humanities, the Office of Research and Academic Services (ORAS) is responsible for managing four tasks which include research and academic support and services, Interdisciplinary Studies Journal, Institutional Review Board (IRB), and library. However, ORAS's main task is to assist its faculty members in raising both research quality and research innovation to help address the faculty's strategies (namely, glocalization, TRS integration, and management eco-system).

Examples of the funded research projects in 2022 include (1) the Project on Addressing the Continuum of Care Among High-Risk Thai Men; (2) Criminal Justice 5G for Developing Innovative Crime Prevention during the COVID-19 Pandemic Situation in Thailand; (3) Research Plan for Building Immunity and Safety from Cyber Threats; and (4) Technologically Creative and Innovative Media to Access Career Information for People with Disability.

For 2023, some of the funded research projects are 1) Discourse Gender and Agency of Female Adolescent and Youth Drinkers; 2) Drinking Norms, Self-Identification, and Perspectives on Alcohol Control Measures among Non-Problematic Young Working-age Drinkers; 3) Examining the Prevalence of Online Elder Fraud in Thailand and Its Psychological Effects on Thai Older Persons; and 4) Perception towards Alcohol Control Policy as Public Policy among New Generation in Bangkok Metropolitan Region.

ORAS's academic endeavors also include supporting and encouraging its faculty members to disseminate their research knowledge through the publications of their research articles in high-quality international journals.

Research Directions

The overall research goals are not only to create positive impacts on society through scientific methods, but also to focus on developing innovative and informed policies that can be used to properly identify and address local, regional, and national problems.

Office of Education and Learning Innovation (OELI)

OELI is responsible for educational administration and learning innovation by improving quality education, developing a modern curriculum responding to the Sustainable Development Goals and changes in the world of disruptive innovation. The OELI is composed of 2 sections as follows:

1. Educational Administration and Students Affairs Section comprises Educational Administration Unit and Students Affairs and Alumni Relations Unit
2. Flexible Education and Skills Development Section



Office of Academic Integration for Society (OAIS)

OAIS is the newest office under Faculty of Social Sciences and Humanities. It consists of four centers:

- 1 Center of Excellence in Sustainable Local Development
- 2 Center of Excellence in Health, Law, and Quality of Life
- 3 Center of Excellence in Research on Gender, Sexuality, and Health
- 4 Center for China and Globalizing Asia Studies (CCGA)

As the name implies, OAIS's main function is to support and connect all the academic and research endeavors generated from these four centers and to help transform them into knowledge and academic services for local communities, their members, and all their stakeholders. OAIS focuses on using the various research lenses to identify and address the local and social issues in an international fashion. It also encourages cooperation and collaboration from members of the local communities and personnel from both public and private agencies to participate in addressing the problems.

In sum, OAIS will be an important academic unit of Faculty of Social Sciences and Humanities that helps connect its mission and the mission of the university that leads to excellence in research and academic services.
